### **COURSE SYLLABUS**

<u>Course Title:</u> Interpreting Practicum & Seminar Course #: INT\* 242

<u>Course Description:</u> Four (4) semester hours. The student will complete at least 60 hours of simulated or practical work experience in supervised settings. This course will also provide an open forum for discussing questions and concerns arising from the student's observation of interpreted situations and individual practicum experiences. In addition students will prepare for securing professional positions upon graduation and establish professional development goals for achieving national interpreter certification. Program experience portfolio presentation will be required at the end of the semester documenting hours, experience and areas of improvement.

<u>Pre-requisite/Co-requisite:</u> Prerequisites – INT\* 212, 231. Co-requisites – INT\* 214, 216, 230, and consent of instructor.

## **Goals:**

- 1. To integrate training and knowledge with on-the-job experiences.
- 2. To develop skills in analyzing various interactions and providing appropriate mediation.
- 3. To understand negotiation of communication and assignments.
- 4. To know how to prepare for securing employment.
- 5. To know how to network.
- 6. To become aware of continuing education/professional development opportunities.
- 7. To develop techniques for stress management and personal health.

### **Outcomes:**

By the end of the course the student will be able to:

- Analyze interpreting situations and determine performance objectives;
- Demonstrate increased receptive and expressive sign language skills;
- Apply the RID Code of Ethics to actual interpreting settings;
- Manage environmental needs of the interpreting situation;
- Deal with direct communication during an interpreting assignment;
- Assess primary participants' degree of satisfaction with communication;
- Assess and recognize one's own communication and interpreting strengths and weaknesses.
- Relate common occurrences experienced by interpreters.
- Identify procedures for self-contract interpreters;
- Demonstrate resume writing skills;
